- 1. That the Party No. 1 shall not leave the course in between before completion of the course. In case the Party No. 1 leaves the course midway, he/she shall have to make the payment of balance fee for remaining period of the course to Party No.2. In case of default, the Party No. 2 shall have the right to recover the above money with interest @ 12 % per annum from Party No. 1 in accordance with the law of the land and Party No. 1 shall also be debarred from appearing in the entrance test for MD/MS Course for the next three years.
- 2. Party No. 1 shall not be undergoing any training at any other Institution and shall not appear in NEET or any other Entrance Examination/Test to be conducted by any University or any other agency for admission to MD/MS courses to be held

during the course of study till the completion of the course. If Party No. 1 is found appearing in any such Examination under any circumstances, the admission of Party No. 1 shall be cancelled and he/she will have to make the payment of balance fee for remaining period of the course to the Party No. 2. In the case of default the Party No. 2 shall be competent to recover the balance fee of the remaining period with interest @ 12 % per annum in accordance with the law of the land.

- 3. If Party No.1 cannot complete the attendance and tenure in three years and is not eligible for final Examination and tenure is extended then Party No. 1 will deposit fees for extended tenure as per the rule.
- 3. That the Party No. 1 after completing the course shall serve the Institute as **Senior Resident** for a period of **one year** in any Medical College under M.M. Trust. The candidate has to complete the Bond period of One Year. Only by mutual consent if there is no Requirement of Senior Resident and the candidate wants to leave the Institute then Party No. 1 will have to pay an amount of Rs. **10 Lacs** to Party No. 2. Party no 1 can only leave before one year after paying the bond money to party no-2. The Party No. 2 shall be competent to recover the amount from Party No. 1.
